During this project, the subjects may experience physical, mental, or emotional discomfort or harassment.

My pool of subjects will include pregnant women, children or involuntary detainees (prisoners).

If you answered "YES" to any of these questions, STOP. You must apply for Expedited or Full Review. If you answered "NO" to all these questions, continue.

My research will investigate the effects of educational strategies.

1b. My research will investigate or compare instructional techniques, curricula, or classroom management strategies.

If you answered "YES" to Question 1 and to either 1a or 1b, you may be eligible for an exemption based on Category 1.
